# Success **Story**

"Hannah" came to Turningpoint through our Lethality Assessment Program (LAP)—a partnership with Pierce and St. Croix County law enforcement that educates victims/survivors of intimate partner violence about their risk factors for homicide. The program connects victims/survivors to Turningpoint and its support and safety planning services.

Hannah has learning disabilities and physical disabilities. which make leaving her husband more challenging.

Earlier this year Hannah's husband was arrested on assault charges and taken into custody by law enforcement. Utilizing the LAP procedures, law enforcement connected Hannah to Turningpoint via the 24-hour crisis hotline. Turningpoint's Client Services Coordinator arranged to meet with Hannah at our New Richmond satellite office.

Hannah was overwhelmed and frightened. Her husband had made bail, and he was going to be angry about the arrest. She needed safety planning. She wanted to know what was going to happen to her and her husband over the following weeks.

Turningpoint's Client Services Coordinator took her time explaining Hannah's husband's criminal charges and what that could mean for Hannah as the victim of the crime. Upon Hannah's request, they discussed potential restraining order options and how to file for divorce. They also discussed obtaining a caseworker for Hannah through the Aging and Disability Resource Center (ADRC). The two of them called ADRC together to facilitate that process.

Hannah stayed in her home, and her husband was issued a No Contact Order. Later in the week after the incident with her husband. Hannah met with the Client Services Coordinator again to complete an Individual At Risk Restraining Order application. The following week, Turningpoint's Legal Services Coordinator drove Hannah to the courthouse to file the paperwork. Hannah was assigned a Guardian Ad Litem who was able to meet with her prior to the hearing. A Turningpoint volunteer transported Hannah to and from the meeting with the Guardian Ad Litem. Hannah relied on Turningpoint for emotional support, safety planning, legal system support, information and referral services, and transportation services.

Hannah has filed for divorce, and she is in the process of moving out of her home. She is in the process of being assigned a social worker to help her continue to identify appropriate resources for mental health and housing. Turningpoint's Client Services Coordinator continues to follow up with Hannah to address her questions about the process.

Hannah has grown a great deal over the last few months after leaving her husband. She is safe, and she continues to work with Turningpoint through the difficult process of removing herself from an unhealthy relationship.

Hannah is just one of the 618 victims/survivors of violence who received assistance from Turningpoint last year.


## History, Governance, and Staff

Founded in 1979, Turningpoint is governed by a 9-12 member volunteer Board of Directors and led by a full-time Executive Director.

Approximately 20 full-time and part-time staff provide client support and retail and administrative services.

# Funding Sources

Turningpoint's annual operating budget is approximately \$1,000,000. Funding is derived from government grant contracts; support from corporations, foundations, and local businesses; individual donors and faith-based institutions; United Way St. Croix Valley; and earned revenue from Second Chances Thrift Store program.

- Only 10-15% of Turningpoint's clients reside in temporary crisis shelter. The remaining 85-90% of our clients receive legal services support, receive assistance with safety planning, participate in support groups, or receive other one-on-one support.
- Turningpoint offers services throughout Pierce and St. Croix Counties. In addition to our River Falls-based crisis shelter, we offer services at the Second Chances Building in downtown River Falls and at a satellite office in New Richmond.
- All services are confidential and free of charge.
